ADDITIONAL STATEMENT OF WITHDRAWAL OF POWER AND RES-ERVOIR SITES IN THE FLATHEAD INDIAN RESERVATION.

FEBRUARY 24, 1910.—Referred to the Committee on Indian Affairs and ordered to be printed.

> DEPARTMENT OF THE INTERIOR, Washington, February 23, 1910.

SR: Section 22 of the act of March 3, 1909 (35 Stat. L., 795), authorizes the Secretary of the Interior to reserve all lands within the Flathead Indian Reservation, Mont., valuable chiefly for power and reservoir sites, and provides that he shall report to Congress such reservations.

By letter dated April 25, 1909, this department advised you of certain withdrawals under the provisions of the act referred to. I now have the honor to inform you that since the date of the previous communication to you on this matter the following-described lands within the Flathead Reservation have been reserved for the purpose mentioned in the act, subject, however, to the voluntary relinquishment of the Indians holding allotments therein, with selections of lieu lands elsewhere:

Dam site No. 3.—T. 21 N., R. 21 W.: W. ½, sec. 6; NW. ½, sec. 7. T. 21 N., R. 22 W: All of sec. 1; lots 1, 2, 3, and 4, sec. 12; area (approximate), 980 acres. Within this site there is one allotment a relinquishment of which has not yet been obtained.

Dam site No. 4.—T. 19 N., R. 22 W.: S. ½, sec. 1; W. ½ NE. ¼ and E. ½ NW. ¼, sec. 12. Approximate area, 480 acres. Free from conflicts, no allotments having been made within the site.
