05/ 2019	HB 564 – An Act relating to cryptocurrency, amending exempt transactions from certain securities law allowing certain digital transactions
05/2019	Montana Passes Bill to Exempt Utility Tokens From Securities Laws - "Big Sky Country" has gone crypto friendly, with new legislation exempting utility tokens from securities laws.
05/2023	SB 178 – An Act generally revising cryptocurrency laws, prohibiting discriminatory digital asset mining utility rates, prohibiting local government power related to digital asset mining, prohibiting taxation on the use of crypto currency as a payment method providing for digital assets as personal property
05/2023	Governor signs pro-cryptocurrency mining bill into law
08/2023	Shane Morigeau Oped re Crypto legislation passed in Montana
